# **Travel Steps:**

## Do you have a passport?

If you do not already have a passport, you must apply for one immediately. PLEASE NOTE THAT IT CAN TAKE OVER 8 WEEKS TO OBTAIN A PASSPORT. DON'T WAIT UNTIL THE LAST MINUTE! If you have a passport, check the expiration date to be sure it has not expired or will not expire while you are in Spain; your passport should be <u>valid for at least six months after</u> your planned departure from Spain, so **its expiration date should be** <u>after January 21, 2021</u>. If it expires before this date, you should plan to renew your passport right away.

Please email Laura a copy of your valid passport ASAP to <u>barcelona@cc.gatech.edu</u>, or visit Laura in the College of Computing building, room 119, to drop off a copy or make a scan or copy. You can also email to make an appointment.

## Do you need a visa?

- If you hold a valid U.S. passport, you do not need to apply for a visa. Your passport acts as your Schengen Tourist Visa.
- If you hold a non-U.S. passport, please consult the following list of countries (listed in Spanish) that do NOT require visas for a stay that does not exceed 3 months within a period of 6 months (Scroll to Page 3, see Section II; common countries include Canada, Japan, and Republic of Korea):

   If the issuing country of your passport appears on this list, you do NOT need to apply for a visa.
- ☑ If your country of citizenship is NOT on this list (common countries include India and China), then you DO need to apply for a Schengen Tourist Visa. Please review the visa application requirements and process in the next section of this handout.

## How to Apply for a Visa for non-U.S. Passport Holders:

- If you are a permanent resident of Georgia, Florida, or South Carolina, you will need to go to the Spanish Consulate in Miami and apply for your visa IN PERSON through "BLS Visa Service for Spain." (Note: If you hold an F-1 student visa assigned to Georgia Tech in Atlanta, it makes your residency within the state of Georgia.) See further instructions below.
- For permanent residents of other states, the jurisdiction for Consulate General at which you will need to apply for your visa will be different, like Houston or Chicago.   Once you have determined your visa jurisdiction, please visit the specific jurisdiction's webpage regarding instructions and timelines for visa applications/appointments, as they differ from jurisdiction to jurisdiction.

  - As of July 1, 2019, appointments should be made in advance through "BLS Visa Service for Spain;" click above website for info on how to book.

- For a list of required items to submit with your application, click the following link and scroll to the second page for "What to Submit": <u>http://www.exteriores.gob.es/Consulados/MIAMI/en/InformacionParaExtranjeros/Documents/Visa%20Requirements.pdf</u> (Please note that you are required to submit a driver's license or state ID; if you do not have a state ID, please apply for one ASAP one through Georgia DDS: <u>https://dds.georgia.gov/georgia-state-id-card</u>)
- Given that visa application may only be requested within 90 days prior to departure, the earliest you can submit your visa application to the Consulate is February 8, 2020. We recommend you plan your trip to Miami for the submission of your visa application during February or before spring break in March; please check their web page for any holiday closures.
- Notice about scheduling your visa appointment or trip (to Miami or another jurisdiction): Please be advised that you should <u>not</u> schedule your visa appointment or trip to the consulate during any major conflicts with your courses. You should refer to your courses' syllabit or ensure you are not missing any major course deadlines, important deliverables, exams, midterms, etc. Please discuss your trip with your professor or instructor if needed.
- Please email Laura at <u>barcelona@cc.gatech.edu</u> if you will need to apply for a visa, as there is some additional documentation that the program will provide for inclusion with your visa application (such as items #7, 8, 9 on the "What to Submit" list above).

## **Getting to Barcelona**

We have arranged a group fare of \$1,368 for those participants who are interested. Prior to ticketing, the airfare may change as the taxes and fuel surcharges associated with the reserved fare are not fixed.

If you would like to participate in the group airfare option, please contact us at <u>barcelona@cc.gatech.edu</u> no later than **January 6<sup>th</sup>.** Please note that participation in the group flight is **optional** and subject to availability (we have a limited number of group flight seats reserved). Also, the group airfare payments are due per the program's published schedule; payment of the group airfare cannot be deferred to the disbursement of scholarship and financial aid funding. If you travel on the group flight reservation, you must follow the above ticketed itinerary. We do not arrange multiple deviations to the group flight for individual students.

If you decide not to participate in the group flight, you are responsible for making your own travel arrangements. Please email us (<u>barcelona@cc.gatech.edu</u>) your flight itinerary once it has been booked. If you would like to join the group airport transportation to/from Onix, please arrange your arrival and departure times as close to the group flight as possible. You may book yourself directly on the same flights as the group, if you wish. Regardless of routing and timing, your arrival and departure dates should follow those of the group flight.

# **Housing Steps:**

## **Room Preference:**

Student housing will be available at *Residencia Onix* (http://www.residenciaonix.com), a modern student residence facility. Double rooms with in-suite kitchens, bathrooms, A/C, and internet are available and included in the program charge. Single rooms with a shared kitchen are available upon request, subject to availability, at a supplement of approximately \$438. If you are interested in a single room, please let us know ASAP by sending an email to <u>barcelona@cc.gatech.edu</u>. Please note that all rooming requests are considered on a first-come, first-served basis, and then given to students in the order of their acceptance to the 2020 program.

*Residencia Onix* has a 24-hour, English-speaking concierge and provides weekly room cleaning of the kitchen, bathroom and change of sheets and towels. The rooms include bedding, bath towels, and an equipped kitchen. The contact information for *Residencia Onix* follows:

#### **Housing Deposit:**

A \$300 housing deposit will be charged to your student account on March 27. This is a deposit which is full to partially refundable depending on the state in which you leave your room at Onix at the end of the program. Please be sure to do a thorough inspection of the status of your room upon check-in at the beginning of the program and mark anything notable. If your room is left unclean, with items missing, or with damage other than how it was marked upon check-in, you may be charged for a cleaning fee or repairs which will come out of your deposit. Refunds (full or partial) will be credited to your student account during the fall semester 2020 and are subject to currency exchange changes.

# **Coursework Steps:**

#### **Registration:**

Registration for Summer Term 2020 will begin on March 23; courses for this program are available on a permit-only basis due to the limited number of seats in each course. Please begin thinking about which 4 courses (12 credit hours) you would like to take as a part of this summer program and select an alternate or two in the event you are not able to register for your 4 preferred courses. Registration permits for courses will be issued based on the order of the student's acceptance into the program and other criteria (e.g. year, major); more information on this process will be distributed during the spring 2020 semester at participant meetings and via email to program participants. The maximum capacity for courses will be enforced; overload permits may be issued in exceptional circumstances.

If you have any questions regarding coursework planning, please contact your academic advisor. If you have any questions concerning the individual courses offered this summer in Barcelona, please review the course information on our website (link to be posted) and/or contact the faculty for the course. Be sure to attend the **2020 Courses Q&A Session** on Monday, **February 24** to learn more about the courses and meet the faculty. #### **Textbooks:**

You will need to purchase your textbooks for this summer prior to leaving for Barcelona. Textbook details for the 2020 courses will be provided no later than the Pre-Departure Orientation on Monday, **March 30**.

## **Program Cost:**

## Financial Aid & Promissory Notes:

Generally, you may apply your financial aid and scholarship funding towards the tuition and fees assessed to your student account upon registration for summer courses. If you wish to apply aid to your tuition and registration fees, please let Dawn or Laura know and provide a copy of your Award Letter that shows your anticipated aid for Summer 2020.

If you wish to apply any of your financial aid towards your program charge costs (\$3,300 payment due 2/7; \$2,200 payment due 3/6), you will need to let us know and provide a copy of your Award Letter that shows your anticipated aid for Summer 2020; and, then you will need to meet with us to review and sign a promissory note which will defer <u>a</u> <u>portion</u> of your program charges due until May when financial aid is typically disbursed for the summer term.

If you did not indicate on your 2019-2020 Georgia Tech Application for Scholarships and Financial Aid (GT APP) that you would be enrolling in summer courses, please email <u>revisions@finaid.gatech.edu</u> immediately to let them know that you will be enrolling in summer classes and studying abroad (be sure to include your gtID in your correspondence).

# **Cancellation and Refund Policy:**

The application fee of \$500 is non-refundable (upon application approval and program acceptance).

Students cancelling participation prior to March 6 must pay the first program charge payment of \$3,300; cancellations after this date will result in forfeiture of all anticipated or paid program fees.

Students cancelling their group flight participation after January 24 are responsible for paying (or forfeiting payment of) the entire group airfare. Name changes after ticketing for group flight participants may be an alternate option to cancellation and are subject to fees established by the travel agent and airline.

Please note that Georgia Tech reserves the right to alter or cancel this program due to low enrollment, unavailability of a professor to teach a planned course, or other unforeseen circumstances. If Georgia Tech cancels the program before the departure for reasons within its control, all fees paid by participants will be refunded. If Georgia Tech cancels the program before departure or while the program is in progress for reasons beyond its control, such as political unrest or danger to participants' safety, only those fees that Georgia Tech is able to have refunded by service providers will be returned to participants.
